Vendor Information

SPACES: Food court space sizes vary (smallest size is 12x12 feet). Location assignments will be based on availability, size of space needed, and power needs. Vendors provide their own furniture and sun/rain cover (canopy or food truck).

COST: \$135 for Friday and Saturday
\$100 for Saturday only
\$25 Premium Location Surcharge (corner spaces on Main Street)
\$25 Discount for Stevensville Main Street Association members (member applications are available from SMSA office, or downloadable from the web site).

DEADLINE: Registration and payment is due no later than Friday, June 8, 2018. Upon receipt of your registration and payment, you will be notified of your space location (first-come, first-served). PRODUCTS: Vendors are encouraged to highlight quality Montana-made or grown products, though other food products are acceptable. Please be thorough and accurate in describing your product on the registration form. Stevensville Main Street Association reserves the right to not accept registrations from vendors. NOTE: Arts and crafts vendors will be located in a separate Arts and Crafts Fair area.

LOGISTICS: Food Court is located on east 3rd Street at Main Street in Downtown Stevensville.

Friday hours: Setup 2:00-4:00 pm
Food Court Hours 4:00-10:00 pm*

Saturday hours: Setup 7:30-10:00 am (no arrival before 7:30 am)
Food Court Hours 11:00 am-10:00 pm*

* Beer Garden and Street Dance run until 10:00 pm both nights

Booths must be staffed at all times during serving hours. Please bring enough supplies to last until closing both nights. No early breakdown.

Parking will be provided at no charge, though availability is not guaranteed. Parking in unauthorized area may result in vehicle being ticketed and/or towed at owner's expense.

Area clean-up is the responsibility of the vendor. Dumpsters will be available nearby for waste.
